CONFIRMATION EMAIL:

Once your registration has been successfully processed, you will receive an email confirmation of your meeting registration containing your hotel booking link. Spouse/Family Member registrations will not receive a separate hotel booking link.

Registration forms will not be processed without payment and all credit card information fields are required. If you do not wish to register online or provide credit card information on the registration form you may register by mail. The confirmation email with the hotel booking link will not send for meeting registrations with a balance due.
